Statutory Public Meeting

A public meeting was held in accordance with the provisions of 34(12) of the Planning Act to consider a Zoning By-Law Amendment for the McIntyre Road Additional Residential Unit. Council approved the application to amend the Zoning By-law (D14-2026-0006) and enacted By-law 2026-49, being a by-law to amend the zoning by-law to permit a Additional Residential Unit (ARU) with an accessory structure within the Prime Agriculture (PA) Zone.

A public meeting was held in accordance with the provisions of 34(12) of the Planning Act to consider a Zoning By-Law Amendment for Lakeside West - Kenlar Investments Inc. - Draft Plan of Subdivision (D12-350) and Zoning By law Amendment (D14-004-2025). Council approved the Draft Plan of Subdivision Application subject to the conditions attached to the report. Council approved Zoning By-law Amendment Application D14-004-2025 and enacted By-law 2026-51.
