4. Conditions

- a. This Authorization Form is effective for a six (6) week time frame:

- b. The hunter or trapper authorized under this Authorization Form shall obtain consent of the landowners and/or occupiers prior to entering private property for the purposes of this authorization.
- c. The hunter or trapper understands that nothing in this Authorization Form permits trespass.
- d. The hunter or trapper agrees to follow all applicable federal, provincial and municipal laws.
- e. The hunter or trapper represents and warrants that they have a valid license to hunt to trap coyotes and wolves and agrees that it will remain valid during the Term.
- f. If the hunter or trapper's license becomes invalid at any time during the Term, the hunter or trapper shall immediately notify the County of Grey and this authorization shall immediately terminate.

- g. The hunter or trapper shall be responsible for disposing of the pelts by methods sanctioned by the Ministry of Natural Resources and shall not abandon or let spoil the pelts of the coyotes or wolves.
- h. Through the Term, the hunter or trapper shall have insurance coverage of 2 million dollars liability insurance or be a member in good standing with the Ontario Federation of Anglers and Hunters (the "OFAH") or the Ontario Fur Managers Federation (the "OFMF") with insurance through the OFAH or OFMF.
- i. The hunter or trapper shall indemnify and hold harmless the Corporation of the County of Grey, and its elected officials, employees, servants and agents from all lawsuits, actions, claims, demands, damages, costs or expenses by whomsoever made in respect of death, injury, loss or damage to person or property, howsoever cause, arising as a result of or in any way connected with my acts or omissions under this Authorization Form, including any acts or omissions of their agents, employees, invitees or other person that they are responsible for.
- j. The hunter or trapper hereby releases, waives and forever discharges the County of Grey, and its elected officials, employees, servants, and agents from any and all lawsuits, actions, claims demands, damages, costs or expenses by reason of death or any injury to the hunter or trapper's acts or omissions under this Authorization Form, including and acts or omissions of their agents, employees, invitees or other persons that they are responsible for.
- k. County may terminate Authorization Form in its sole discretion if:
 - i. It was authorized on mistaken, false or incorrect information
 - ii. It was an authorized error;
 - iii. The landowner or hunter or trapper requests that it be terminated;
or
 - iv. Any term or condition in this Authorization Form or By-law 5300-26 has not been complied with.
